



Privacy Policy Statement

We at DMI are committed to respecting your online privacy and recognize the need for appropriate protection and management of personal identification information ("Personal Information") you share with us.

Personal Information includes any information that may be used to identify you, such as: first and last name, home or other physical address, telephone numbers, e-mail addresses, or other contact information that is provided to us by you, or any other party. In general, you may visit DMI web pages without telling us who you are or revealing any Personal Information about yourself. You should be aware that if you choose to provide us with your Personal Information, we may transfer that Information, between the various brands of DMI or to a third party service provider to enhance our ability to communicate with you. At no point will we sell your information to any third party marketing service that we do not use to improve our customer relationships. COOKIES AND OTHER TRACKING TECHNOLOGIES

When you visit a DMI website, you can browse the site anonymously and access important information without revealing your identity. In order to analyze and improve our site, we may use "cookies" to track your visit. A cookie is small amount of data that is transferred to your browser by a Web server and can only be read by the server that gave it to you. It cannot be executed as code or deliver viruses. Most browsers are initially set to accept cookies. You can set your browser to notify you when you receive a cookie, giving you the chance to decide whether or not to accept it. (For some Web pages that require an authorization, cookies are not optional. Users choosing not to accept cookies will not be able to access those pages.) While we may use cookies to track your visit on our websites, and our Web servers automatically log the IP/Internet address of your computer, this information does not identify you personally and you remain anonymous unless you have otherwise provided us with personal information.

To protect your privacy, we have adopted the following principles:

NOTICE:

DMI will only collect Personal Information where it is relevant for the purposes for which we are collecting it. We will not process any Personal Information for any purposes that are incompatible with the purposes for which it has been collected or subsequently authorized by you.

CHOICE:

You may choose whether or not to provide Personal Information to a DMI website. However, when you engage in certain activities on a DMI website we may ask you to provide certain information about yourself by filling out and submitting an online form. It is completely optional for you to engage in these activities. If you elect to engage in these activities, DMI may require that you provide certain personal information, such as your name, mailing address, e-mail address, and other personal identifying information.

SECURITY:

Wherever your Personal Information may be held by DMI or on its behalf, reasonable and appropriate precautions will be taken to protect such information from loss, misuse or unauthorized access.

ACCESS / ACCURACY:

To the extent that you do provide us with Personal Information, DMI wishes to maintain it accurately. Where we collect Personal Information from you, our goal is to provide a means of contacting us should you need to update or correct that Information. Further, if you notify us that such information is incorrect, or you wish to have such information removed, we will correct, amend, or delete your Personal Information as soon as practicable.

CHILDREN'S PRIVACY:

DMI websites are not structured to attract children. Accordingly, we do not intend to collect Personal Information from anyone we know to be under 13 years of age. If we are made aware that information is or has been submitted by or collected from a child under the age of thirteen, we will delete this information.

SENSITIVE INFORMATION:

DMI does not collect Sensitive Information such as medical, health, racial, ethnic, political, religious, philosophic, union membership or sexual orientation information. If we are made aware that we have received such information, we will delete this information.
